IT'S THE LAW (ORC 955.21)

All dogs three months of age or older must be licensed. No dog shall be harbored, kept, or owned without displaying a valid registration tag.

(The law applies regardless of whether the dog is kept inside or out.)

INSTRUCTIONS FOR ASHTABULA COUNTY DOG LICENSES:

ON-LINE

Register your dog on-line at www.doglicenses.us/OH/Ashtabula. Credit card payments only; \$2.00/license processing fee applies. To access your pre-filled form you will need your Account ID and Password listed below.

BY MAIL

- 1. Complete this form. Be sure the correct owner, street address, and pet description(s) appear on all applications.
- 2. Use this form to register 1 to 5 dogs. If you have more than 5 dogs, please list them on a separate sheet of paper and return it with this form. Ohio law requires a license for every dog more than 3 months old.
- 3. Before January 31, licensing rate for a one year tag is \$12.00 per dog. Enclose a check or money order for the correct fees payable to: Ashtabula County Auditor. Please do not send cash. Your application cannot be processed without the correct fees. Statutory late penalty increases the licensing rate to \$24.00 per dog AFTER January 31.
- 4. Please return the application and a check or money order in the enclosed return envelope. A receipt will be returned to you with your 2016 license tag(s).

IN PERSON

You may purchase the tag(s) in person at the Ashtabula County Auditor's Office, 25 West Jefferson Street, Jefferson, Ohio 44047. Please bring the attached form when purchasing tags. Cash, checks, and money orders are accepted. No credit or debit cards.

REGISTER

Registrations are accepted at the Ashtabula License Bureau, Jefferson License Bureau, Kray Feed, Pleasant Animal Hospital, and Saybrook Feed. They collect a \$.75 fee per dog. Allow for a couple weeks to process and license tags to be mailed from the Auditor's Office.

THREE YEAR TAG

APPLICATION for the registration of dog(s) for the year 2016

Before January 31, the license rate is \$36.00 per dog. The tag is non-refundable and cannot be transferred to a different dog.

LIFETIME TAG

Before January 31, the license rate is \$120.00 per dog. The tag is non-refundable and cannot be transferred to a different dog.
